



# How to use Options Data:

Last article I have tried to simplify the terminology of options and had said in the next issue we will see how we use options data to trade or invest. Lets refresh some of the terminology again. There are four types of

Writing a call option means that you are selling a call option. If you sell a call (also know as a "short call") then you are obliged to sell stock at the strike price. Typically, a call is sold against long stock. For example, if you bought a stock when it was trading at \$100 and you sold a \$105 call for \$4.

A put is a strategy traders or investors may use to generate income, or buy stocks at a reduced price. When writing a put, the writer agrees to buy the underlying stock at the strike price if the contract is exercised.

Writing, in this case, means selling a put contract in order to open a position.

Hence call option data and put option data is used to find out levels of the market.

Call writing (means short call which means shorting the market ) at particular level gives an indication where the resistance is basis seeing number of contracts.

Hence maximum call written at a particular level gives an indication that traders /investors will be shorting at that particular level and hence its acts as resistance. Please note as of today live example of Indian market data on call writing would be as under:



# Call options data

Maximum Call open interest (OI) of 32.59 lakh contracts was seen at the 11,600 strike price. It will act as a crucial resistance level in the last week of the July series.

This is followed by 11,500 strike price, which now holds 31.43 lakh contracts in open interest, and 11,700, which has accumulated 29.89 lakh contracts in open interest.

Significant Call writing was seen at the 11,400 strike price, which added 29.42 lakh contracts. So these levels gives pain in immediate and long term where the resistance of the market lies.

Significant Call writing was seen at the 11,400 strike price, which added 2.94 million contracts. So these levels gives gain in immediate and long term where the resistance of the market lies.

Put writing (obligation to buy) at particular level gives an indication where the support is basis seeing number of contracts. Hence maximum put written at a particular level gives an indication that traders /investors will be supporting at that particular level hence its support .Please see as of today live example of Indian market data on put writing.

## Put options data:

Maximum Put open interest (OI) of 3.81 million contracts was at 11,300 strike price. It will act as a crucial support level for last week of the July series.

This is followed by an 11,200 strike price, which now holds 2.20 million contracts in open interest and at 11,000 strike price, which has accumulated now 1.96 million contracts in interest. open

Another important data for trading or investment which should be read along with call and put data is the stock delivery % where one wants to invest.


If put option data suggest market is heading up and one wants to invest in any particular stock and that stock data suggest a high delivery % then one can expect significant upside basis these two correlations of put option data and stock delivery %.

As of date above Indian data suggest one can look at following options to go long in individual stock.

### Stocks with a high delivery %

High delivery percentage suggests that investors are accepting delivery of the stock, which means investors are bullish on it.

# NEWS FROM FRONTIER & EMERGING MARKETS WE FOLLOW

#### **USA**

### Digitian Country Rating AAA

- » USA market remains volatile through out June 2019 mainly due to uncertainty in US-China trade but the market completelty recovered and gained 6-8% from the last month dip. due to fed rate cut possibility and resumption of trade talk. It is expected that July will see some continuation of the bull runand setting of the new high with the ensuing earning seasons starting mid July
- » The recovery was mainly driven by FAANG stocks and tech stocks.
- » Oil prices continues its sharp correction after dip in month of May, further 5-7% due to over USA supply and expected slowing world demand.

#### India

# Digitian Country Rating AA

- » Post Election bull run halted in the month of June however, given the slowing economic performance, it seems the economy needs a boost from the Government and the upcoming Budget will be very important.
- » GDP growth has been surely slowing. Inflation slightly inched up further. However, Currency is appreciating against Dollar which may not be good for Export Sector.
- » NIKEI India Manufacturing PMI Up 52.7% in May while RBI has cut its policy rate by 25 basis points;

#### China

# Digitian Country Rating AA

- » China Market continued its fall for the third month with some resistance in picture. It may turnaround dramatically if the trade talk starts;
- » According to Chinese Government statistics, China has seen current account surplus in Q1 with growing demands for goods and it grew faster than expected at 6.4% in Q1.

## Kenya

# Digitian Country Rating B+

- » Kenya market is in the grip of a bear run completely eroded the entire gain of the year and dropping sharply by 1.6% due to a very dismal state of affairs of the country. We are expecting further fall within a range for this month as well
- » After India Kenya started the process of Demonetization since May 31 by introducing new KES 1000 note. The process is expected to be completed by October 2019. So the economy will be in Turmoil during this period;
- » Kenya's Tshiling slided further given the announcement of demonetization. Private Sector credit growth was marginally high at 5.2%

#### Ghana

# Digitian Country Rating C

- » Ghana Stock market is oscilating with a dip in June by 3.8%; overall the market is still down around 7.9% year till date
- So Shana's economy: the IMF talks of a growth rate of 8.8% in its World Economic Outlook, which would make Ghana the fastest growing economy in the world in 2019. The cedi's sharp dive against the U.S. dollar still continued for the second month;



## Egypt

## Digitian Country Rating B-

- → Egypt EGx30 index recovered from the last month drop and registered a gain of 2.6%. while Trade deficit shrunk by 7.8% yoy; but inflation remain a problem
- → Egypt will get USD 9.1 Bln in investment out of Middle East package of USD 50 bln from Trump Administration.
- → State owned Companies selected for Initial Public Offerings will be taken in the Second phase of Divestment to commence soon;

#### Tanzania

### Digitian Country Rating C

- → The economy seemed to coming back in track in the later half of the 2019. Credit growth was robust. Moreover, exports continued to increase, for the fourth month, on the back of rising foreign sales of gold and higher travel and transport receipts
- → Tanzania Inflation increased to 3.5% p.a. However, the Tshiling also depreciated after few months of stability;
- → Tanzania Natural Gas Power Requirement increasing in 2019; Tanzania to double its rice production by 2030;

#### Nigeria

## Digitian Country Rating D

- → The volatality in the oil price and all-important energy sector, which contracted for the fourth consecutive quarter led the slowdown.
- → After MTN, Airtel is getting listed in the Nigerian Stock exchange
- → Nigerian Industrial PMI dropped to 52.9 from 55.1 but still it is better than other African countries

#### Bangladesh

## Digitian Country Rating BB

- → In June, Bangladesh market witnessed a solid growth of 2.8% which may start the bull run
- → The budget increases expenditures by over 13% and targets a fiscal deficit of approximately 5% of GDP, up from the expected shortfall in FY 2019
- → Bangladesh planned to invest heavily on skill development programme to make its 60 million population in the 18-24 years, ready for new age industries;


# Crypto Currency (CC)

Another major trend for Millennial and DIGITIAN is Crypto Currencies. A crypto currency is a digital asset designed to work as a medium of exchange that uses strong cryptography to secure financial transactions using distributed ledger technology or Block chain. The first decentralized cryptocurrency, bitcoin, was created in 2009 by pseudonymous developer Satoshi Nakamoto. It used SHA-256, a cryptographic hash function, Soon after, in October 2011, Litecoin was released. It was the first successful cryptocurrency to use scrypt as its hash function instead of SHA-256. Since the release of bitcoin, over 4,000 altcoins (other cryptocurrencies) have been created and some of the most famous names are Ripple, Ethereum, ZCash, Monero, Litecoin etc.

A cryptocurrency wallet stores the public and private "keys" or "addresses" which can be used to receive or spend the cryptocurrency. With the private key, it is possible to write in the public ledger, effectively spending the associated cryptocurrency. With the public key, others can send currency to the wallet.

Cryptocurrency exchanges allow customers to trade crypto currencies for other assets, such as conventional fiat money, or to trade between different digital currencies. An initial coin offering (ICO) is a controversial means of raising funds for a new cryptocurrency venture. According to PricewaterhouseCoopers, four of the 10 biggest proposed initial coin offerings have used Switzerland as a base, where they are frequently registered as non-profit foundations.

Bitcoin is the topmost crypto currency in terms of followers and speculative value. It first started going up in 2013 but for the next 3 years remains just over US \$ 1000, in 2017 it started its J curve from US \$ 1350 to US\$ 19677 in December 2018 (a growth 14.4 times in a single year) then dropped suddenly from January 2018 it dropped to go love as US\$ \$ 3000 till May 2010 before giving again in the last 2 months to USD 12200 (4 times)



The question is why this flactuation, which is not suitable for a reliable currency, more than its transactional value the value is driven by speculation of the future demand. Apart from that the current form of crypto currencies has the following drawback: Anonymity, Determination of value, unregulated, opaque structure, use in darknet Legality: Most of the major countries have either directly /indirectly banned trading of CC. Even advertisement of CC in the social media is completely banned even in China and Russia (To avoid AML/ drug cartel/ terrorism funding

• Facebook recently published the intention to launch "LIBRA" a CC. The plan is for the Libra token to be backed by a basket of currencies and US Treasury securities to avoid volatility. Facebook formed a Libra Associations in Switzerland with 27 global partners payment, technology, telecom, online marketplace, venture capital and nonprofits. including Visa, Mastercard, The blockchain's distributed ledger will be used for reconciliation between service partners. This is much more palatable but still this initiative needs more regulation to be acceptable by all countries.
