The diffusion index for current activity decreased 6 points to 26.3 in November, its sixth consecutive positive reading after reaching longterm lows in April and May (see Chart). The index for new orders decreased 5 points to a reading of 37.9. Nearly 49 percent of the firms reported increases in new orders this month, compared with 55 percent last month. The current shipments index fell 22 points to 24.9 in November. Nearly 41 percent of the firms reported higher shipments, compared with 57 percent last month.

Thus, Diffusion Index shows continued recovery

Have You missed the rally - so what next?

A year which is just few weeks away—we want to see this year end and some may want to forget. BUT from an investor perspective some may have made their greatest return of life and some may have booked their greatest losses in life—i t all depends how you have acted in last 2 quarters!

Few days back I came through an interesting chart (Psychology of a market cycle) –"the feeling appearing as the market fluctuates".

What may be going through your mind is have you missed the rally? Please read what Mogan Housel had to say regarding this in his recent article.

..... "It's easy to ignore the power tail events because it's painful to accept that most of what happens isn't that important. Over the last 20 years, 9/11, Lehman Brothers' collapse, and Covid-19 were pretty much the only economic headlines that moved the needle.

"Given the growth prospect in the emerging markets and the relatively cheaper valuation of EM stocks vs US stocks are attractive"

will likely provide all of your lifetime returns, and how you behaved in March 2020 was probably more important than what you did in the previous 100 months combined. Not a fun thing to accept, even if it's reality....."

Now, lets see the context which is beautifully articulated by Jurrien Timmer who is the director of global macro in Fidelity's Global Asset:


- After a decade of trading relatively sideways while the US stock market went up, emerging markets (EM) stocks seem finally poised to outperform in 2021 and beyond.
- A weaker dollar is key to this trend. The dollar has been declining since March as a result of all the liquidity provided by US policy makers and the Fed, and I expect this trend to continue next year and beyond.
- Earnings growth is another essential component of the bullish EM story. Indeed, with the promise of vaccines, global earnings are primed to recover further in 2021.
- With EM stocks trading at their lowest relative valuation to the US in almost 20 years,





Assume, like many, you are in disbelief how can the market rise when Covid vaccine is still not rolled out or the real economy is not doing well. Please remember market is forward looking and hence market discounts the future which has exactly happened now.

Think of all the attention that went to everything else and ended up not making much difference; it's depressing. Same with investing: make 50 investments and 10 or fewer – maybe only one or two –

 EM stocks could be one way to diversify the stock segment of your portfolio without having to pay skyhigh valuations. Amongst the emerging markets, Brazil is not in great shape and China has issues which have made it almost pariah and untouchable in the China +1 strategy (see below). Whats the reality now —To me China is a big power now, hence cannot be fully ignored. Having said that almost the the entire world who depends on China on supplies is looking at an alertanative to China. In this China+1 strategy, I feel India will play a big role. If we were to believe in data we are already seeing the shift.








Just to elaborate on above point of liquidity - the reason is easy to understand; if you are a managing American pension fund, you need to gun out at least 6% to keep your stakeholders happy. If the US 10-year bond yield is at 0%, how will you get to 6% without investing heavily in emerging markets?

Sovereign Flow funds more flowed in India than China which could be a major shift and will fuel the growth in Indian market. So keep investing and ride the wave.
